Governing Document

The governing document of the Pennyghael Community Hall is its constitution (version 2.1) which sets out its overarching objectives to promote, manage and operate the Hall for the benefit of the communities surrounding Pennyghael and the general public.

Activity

Following on from our application for grant funding from the Healthy Islands fund, work has now begun on our renovation and building work. A complete new state of the art kitchen has been purchased and is now being stored in the hall ready for installation when the building work has been completed. We have therefore, sadly not been able to run any of our usual events at the hall this year apart from its being used as a polling station during the local elections held in May. We are looking forward to holding activities at the hall again once the works have been completed.

We have continued to maintain our website and also to display a good number of interesting historical photographs as we work with the 'Pennyghael in the Past: Historical Archive'.

In order to keep the hall's profile in the mind of those in our local community we have decorated the outside of the hall in order to celebrate Christmas, the Queen's platinum jubilee and Halloween. We have also kept the community informed with regular newsletters and posts and pictures on our facebook page.


Hall Renovations

With generous funding from various grant making bodies, local businesses and individual members of our community we have been able to begin our renovation works. Now that planning permission has been agreed a builder has been employed and he will start in December 2022. Works will include a complete renovation of the kitchen, the building of a new accessible toilet and a ramp to the main front doors of the hall giving easy access to wheelchair users.

Prior to the builder's formal start, we began the work of preparation, clearing out the old kitchen and decorating areas of the hall ourselves. We were also able to install a satellite wifi system and landline phone at the hall.

In December 2021 we were pleased to employ Charlotte Lines as our part time Community Development Officer following funds being given for this in the earlier Adapt and Thrive grant.





Finances

During the year we received and spent the Healthy Island Fund moneys which we had already applied for. This money was given specifically for refurbishing the kitchen and enabled us to buy brand new superior equipment throughout rather than the second-hand equipment we had originally thought we might have to purchase. In addition to this there were donations from a local estate and individuals.

Once again, our thanks go to Mr. Rob Jones who acted as our financial independent inspector. We shall be appointing a new independent inspector as Rob is stepping down after this year's inspection. We have been grateful for his support and wisdom over the last 5 years.

Our thanks go to the wonderful team of volunteers who continue to give generously of their time to keep the hall running for the benefit of the community.
